

State of 911 Webinar FAQ: Federal Communications Commission Update & Safe Streets and Roads for All (SS4A) Grant Program

What would be the benefit of routing a 988 call to a call center in the same area?

Routing a 988 call to a local call center improves response times and ensures more accurate support by leveraging regional knowledge. Callers benefit from personalized assistance, as local call takers better understand community-specific needs, including EMS and mental health services. Additionally, local centers can coordinate more effectively with nearby services, enhancing the overall efficiency of crisis response.

Would the reduction of EMS times also be included for this program; we have areas with long response times due to distance.

The Safe Streets and Roads for All (SS4A) discretionary grant program is focused on improving roadway safety for all users by reducing and eliminating serious-injury and fatal crashes through the development, refinement, and subsequent implementation of comprehensive safety action plans (referred to as "Action Plans"). Implementation Grants fund projects and strategies that address a roadway safety problem identified in an Action Plan. Eligible activities can include infrastructure, operational, and behavioral intervention. Equipment and other purchases need to be directly related to the implementation of the project and strategy to address the roadway safety problem. PPE and gear could be potentially a part of a broader set of projects and strategies within an Implementation Grant if it is not using federal funds to replace general operating costs of a local government (2 CFR 200.444).

Could a community or regional deployment of Emergency Medical Dispatch be considered?

The DOT's SS4A grants encourage EMS systems to develop plans to address roadway crashes in their community and apply for planning and demonstration grants. Eligible recipients include a political subdivision of a state (such as a county, city, town, borough or special district), metropolitan planning organizations, and federally recognized tribal governments. Could a governor appointed 911 Board be considered a subunit of a state? Individual PSAPs may have difficulty accessing these funds without some assistance from their quasi-state level partners, etc.

Yes, a governor-appointed 911 Board can be considered a subunit of the state, as it operates under state authority. Eligible applicants are described here, which includes political subdivisions of a State: Eligible Applicants for SS4A | US Department of Transportation.
